## Scripture Insights

*Please consider the following commentary on this Sunday's readings: Proverbs 31:10-13, 19-20, 30-31; Thessalonians 5:1-6; Matthew 25:14-30*

### THE GOD WHO NURTURES US

"The image of God nurturing his people casts some light on today's Gospel. At first glance the master who goes abroad seems far removed from the God who feeds his people. But it is important to remember that although the master is abroad the servants are still his servants and the talents he gives them are his talents. All that they do will be done in his name and under his authority. He may be absent but he has put his trust in these servants and he asks them to return this trust by trusting in him; that he will reward them for the work they have done on his behalf.


The first two servants have secure relationships with their master. He has nurtured them and they return his trust by trusting in his goodness to them. The talents they earn do not make them independent of him, but enable them to enter more fully into his happiness. There is a virtuous circle of love and trust, such that the more that they have the more they will be given.

The third servant acts as if he has no relationship with his master. When confronted by the master he makes the excuse that he was afraid and so hid the master's talent. But if he was truly afraid he would have invested his master's money rather than hiding it. He accuses the master of being a hard man, but the master sees through this excuse and turns it back on him. A servant who is afraid of his master is at least in some kind of relationship with the master, and a good master will seek to overcome this servile fear by turning it into a loving filial respect. The problem with the third servant is that in his own mind he has no relationship with the master, and so the master confirms him in his isolation, consigning him to the dark.

Yet we know that God will never abandon his people, even and especially those who live their lives as if they have nothing to do with him.

It is into the darkness of this world that God sends his eternal Word, the light who shines in the darkness. From the cross Jesus Christ reaches out to those who dwell in the night. Through his broken body he binds up those who are lost in this world, gently nurturing those who allow him to heal their wounded isolation, inviting them to come and share in their master's joy. And so we are called to reach out to those who are poor in love, using all that God has entrusted us with, so that through Jesus Christ our praises will be sung at the gates of the eternal city."

# REPORT ON THE FINANCIAL STATE OF HOLY NAME OF JESUS PARISH FOR THE FISCAL YEAR ENDING AUGUST 31, 2020

---

This financial report for the fiscal year that ended August 31, 2020 will cover three main topics: (1) parish operating income and expenses, including our current fiscal year budget; (2) our debts and obligations, including the Annual Catholic Appeal; and (3) our Capital Plan and possible future developments. All three of these areas are interconnected and since we do not have unlimited financial resources, we are constantly balancing these three items.

This year's financial report must be understood in the context of COVID-19, which closed the church from mid-March through the end of June, continues to limit the size of our congregations for Sunday Masses, baptisms, weddings, and funerals, and also continues to limit our ability to conduct fund-raising events. Fortunately, many parishioners have made their weekly offerings even when the Church was closed. Several especially generous donors made extra donations, and we received a Small Business Association Payroll Protection Program (SBA PPP) loan through the federal government's CARES act. Thus, the adverse financial impact of the virus from mid-March through the end of our fiscal year on August 31 was somewhat mitigated. However, the ongoing coronavirus situation continues to reduce our Sunday Mass attendance (down to about 200 total at our five weekend Masses from our pre-COVID average of about 550 attendees per weekend). All of this serves as a reminder that the parishioners of Holy Name need to remain steadfast in our commitment to the visible presence of Jesus and his works. We will be hearing more about this in the upcoming weeks as the current Parish Stewardship Program unfolds.

With respect to the recently completed fiscal year, the first topic is operating income and expenses, including our budget. This is basic and every parish is expected to maintain a balanced budget which means that income must cover expenses. We are pleased to report that for the fiscal year that ended August 31, 2020 our total revenues or income exceeded our total expenses by about \$117k, increasing our net worth (i.e., the difference between our total assets and total liabilities) to nearly \$385K. You may recall that our net worth, or fund balance, went positive two years ago after being negative for several years.

These positive results are due mainly to your generosity to Holy Name. Total collections (Sunday, Christmas, Easter, and other) were down this fiscal year from the prior year. Revenues from weddings, baptisms and funerals, and from fund-raising events, were also down from the prior year. These declines were offset by several large donations. We were able to keep our expenses within what we had budgeted, thereby producing a net gain of slightly over \$117k.

The second topic is our debts and obligations. Here we have the outstanding loan on the 2013-2014

church restoration, the Generations of Faith (GoF) obligation, the Annual Catholic Appeal (ACA), and repayment of the SBA PPP loan. We have been using the overage from the ACA to pay off the GoF obligation (which is \$36,715 each year for another three years), while the outstanding balance on the church loan is being paid off using retained payments from our 2013-2018 Church Restoration Campaign and rents from the Brothers' House. At the end of the last fiscal year, our outstanding GoF obligation was \$110,145 and the outstanding balance on the church loan was \$344,362. These are significant dollars. However, the way is clear as to discharging these debts. That is, the current ACA that is ending this calendar year has provided us with overage for another payment that will be made to GoF and, if we continue to conduct successful ACA's in the future, the GoF obligation will be discharged in December 2022. With respect to the church loan, any extra donations the parish receives will be used whenever possible to increase the retained Campaign dollars, most of which are earning interest in a highly-secure Diocesan money market account with the goal of paying off the church debt once the outstanding loan balance is reduced to the retained Campaign dollars. Based on existing Campaign dollars, this will happen in the spring of 2022. The retained campaign dollars currently total about \$170K and are earmarked to paying the church loan. It should be noted that these dollars are about half of our current fund balance and, because they are earmarked to reduce the debt, they will not be used for operating expenses or any unexpected expenses that may come up in the future. We are also depositing ACA overage dollars in that secure Diocesan money market account earmarked to pay down the GoF obligation. The SBA PPP loan has a forgiveness provision for the money that is used to cover payroll and other specific operational expenses; otherwise, it will be paid off at a 1% annual interest rate. We expect most of the loan will be forgiven and are waiting for final instructions as to the timing and mechanics of the forgiveness provision.

And that brings us to the third topic – our Capital Plan and future developments. These are areas of great uncertainty and could adversely impact the plans outlined above. Concerning the Capital Plan, we have made essential repairs and performed essential maintenance to our aging buildings, but we have a Capital Plan that includes many very expensive items of “deferred maintenance” (e.g., the repair/replacement of the sidewalks around the four sides of the parish campus) that have been postponed due to lack of funds and which may have to be addressed soon, even if that would entail additional borrowing. Our Finance Council and Buildings Committee are looking at these matters closely.

Concerning future developments, we are now almost three months into our second Fiscal Year of the COVID 19 pandemic, which will almost certainly continue to negatively impact church attendance, collections and traditional fund-raising. We cannot realistically expect to again receive many of those larger donations that were so important to the parish last spring and summer. We therefore all have to do our best to maintain and increase the number of documentable regular donors, both to help us through the current Fiscal Year and to keep the Parish fiscally sound for the post-COVID months and years. Responding to our current Parish Stewardship Program is a simple way to help us document the number of families and individuals who identify with Holy Name of Jesus. Even if you are not able to increase your level of giving at this time, please send in your response card with up to date phone numbers and emails. ## **MEMORIAL OF THE PRESENTATION OF THE BLESSED VIRGIN MARY - NOV. 21**


